# 参会人员简介

## CVs of Participants

### 一、中方参会人员（Chinese Participants）

#### 1、胡文丽（HU Wenli）

自2021年7月起担任中国联合国协会（联协）副会长兼总干事。毕业于北京大学经济学院，曾在外交部政策司、中国驻美国使馆、驻澳大利亚使馆工作。来联协履职前，担任外交部国际经济司副司长，深度参与两届“一带一路”国际合作高峰论坛、G20杭州峰会、金砖国家领导人厦门峰会、世界经济论坛年会和夏季达沃斯等重大外交活动的筹备工作。



Ms. HU Wenli has assumed the post of the Vice-President and Director-General of United Nations Association of China (UNA-China) since July, 2021. Ms. HU graduated from School of Economics, Peking University. She used to work in Policy Planning Department of Chinese Ministry of Foreign Affairs, Chinese Embassy in the United States of America and Chinese Embassy in Australia. Before she joined UNA-China, Ms. HU acted as the Deputy Director-General of Department of International Economic Affairs of Ministry of Foreign Affairs, China, and was deeply involved in preparatory work of many prominent diplomatic events, such as Belt and Road Forum for International Cooperation, G20 Hangzhou Summit, BRICS Xiamen Summit, and China's participation in Annual Meeting of World Economic Forum and "Summer Davos" (Annual Meeting of the New Champions).

## 2、王颖 (WANG Ying)

曾长期在外交部国际司工作，曾在常驻联合国工业发展组织代表处、驻乌干达使馆、常驻联合国日内瓦办事处和瑞士其他国际组织代表团、外交部驻香港特别行政区特派员公署工作。她自 2018 年起任中国联合国协会副总干事。



Ms. WANG Ying has long served in Department of International Organization and Conferences, Ministry of Foreign Affairs of China. She used to work in Permanent Mission of China to United Nations Industrial Development Organization (UNIDO), Embassy of China to Uganda, Permanent Mission of China to the United Nations Office at Geneva and other International Organizations in Switzerland, Office of the Commissioner of the Ministry of Foreign Affairs of China in the Hong Kong Special Administrative Region. Since 2018, she has assumed the post of Deputy Director-General of United Nations Association of China.

## 3、张贵洪 (ZHANG Guihong)

现为复旦大学国际问题研究院联合国与国际组织研究中心主任、教授。兼任中国联合国协会常务理事、上海联合国研究会副会长兼秘书长。主要研究方向有联合国、国际组织、全球治理等。



Zhang Guihong is professor and Director of Center for United Nations Studies at Fudan University. He is a member of Executive Board of United Nations Association of China, and Vice President and Secretary General of Shanghai United Nations Research Association. His main

research field includes the United Nations, international organizations and global governance.

#### 4、李开盛 (LI Kaisheng)

李开盛，上海社会科学院国际问题研究所副所长、研究员。2004年获国际关系硕士学位，2008年获得国际关系博士学位。从2004年7月至2013年3月，他在湘潭大学从事国际关系专业的教学与研究工作，先后被评为讲师、副教授。2013年4月，他加入上海社会科学院国际问题研究所，2015年底被评为研究员。2015年3月至9月，



他在菲律宾大学亚洲中心访学。2016年8月至12月，他在韩国峨山政策研究院担任访问研究员。2017年底担任上海社会科学院智库建设处副处长。2019年1月起任上海社会科学院国际问题研究所副所长。其研究范围包括中国外交战略、东亚安全、“一带一路”研究、非传统安全研究和国际关系理论等，出版过的专著有《理解中国外交：民族复兴进程中的国家身份探求》《人、国家和安全治理》《第三方与大国东亚冲突管控》和《遇见菲律宾：一位中国学者的旅菲散记》等，另发表了大量的学术论文与评论文章。

Prof. LI Kaisheng, Deputy Director and Research fellow, Institute of International Relations, SASS. Prof. Li received his MA in 2004 and Ph.D. in International Relations in 2008. From July 2004 to March 2013, he served as lecturer and then associate professor in Xiangtan University. In April 2013, he joined SASS Institute of International Relations as an associate research fellow and was promoted as research fellow in the end of 2015. He was the visiting scholar of Asian Center in University of the Philippines (Mar.-Sep., 2015) and the visiting research fellow of the Asan Institute for Policies Studies in Seoul from August to December, 2016. He



was appointed as the deputy director of SASS think tank coordination office in December 2017 and deputy director of SASS Institute of International Relations in January 2019. His research interests include China's foreign strategy, East Asian Security, Belt and Road Initiative, Non-traditional security and International Relations theories. He has published three monographs: *Identity, National Revival and China's Foreign Strategy* (2011), *Human, State and Security Governance* (2012) and *Third Parties and Conflict Management in East Asia* (2018). He published dozens of research articles in academic journals and a large number of reviews in newspapers.

#### 5、张薇薇 (ZHANG Weiwei)

中国国际问题研究院国际战略所副所长、副研究员。主要研究方向：中美关系、美国印太战略、科技外交、公共外交等。2010-2020年在中国国际问题研究院亚太研究所工作。曾在日本筑波大学担任访问学者两年。在《中国日报》、《环球时报》以及学术期刊等发表作品数十篇。连续11年主笔《国际形势和中国外交蓝皮书》“中国公共外交”章节。



Zhang Weiwei is Deputy Director of the Department of International Strategic Studies at China Institute of International Studies (CIIS). Her major research areas include: US policy toward Asia, China-US relations, regional economic cooperation, science diplomacy, public diplomacy and etc. She has published numerous academic articles and critiques including on China Daily and Global Times. Her recent articles cover US Indo-Pacific Strategy, US-China 'Delink', IPEF, US-European Trade and Technology Council and so on. She was visiting scholar at Tsukuba

University 2008-2010. She has authored the Chapter of Chinese Public Diplomacy in the CIIS Bluebook on International Situation and China's Foreign Policy for 11 consecutive years.

#### 6、周太东（ZHOU Taidong）

中国国际发展知识中心处长，国务院发展研究中心副研究员，主要从事国际发展合作、“一带一路”、全球治理、中国发展经验等相关研究。参与编写《中国落实 2030 年可持续发展议程进展报告 2017、2019 和 2021》，在《人民日报》《China and World Economy》《国际经济合作》《国务院发展研究中心调查研究报告》等发表论文 40 余篇；



合著《对外援助规制体系比较研究》（获商务部优秀奖）、《老挝与“一带一路”》、《尼泊尔与“一带一路”》等著作；主持外交部“一带一路”规则标准互联互通、碳中和背景下的绿色“一带一路”建设、协同推进全球发展倡议与“一带一路”建设、《全球发展报告》等课题。获中国农业大学人文与发展学院管理学博士、澳大利亚国立大学克劳福德政府与经济学院公共政策硕士。

Dr. Zhou Taidong currently serves as Director and Researcher at the China Center for International Knowledge on Development (CIKD), a think tank affiliated with the Development Research Center of the State Council. His research focuses on China's development knowledge, international development cooperation, South-South Cooperation and global development. He holds a Ph.D. from China Agricultural University, a Masters of Arts (M.A.) in Public Policy from the Australian National University, and a Master of Laws (LL.M) from the China University of Political Science and Law. He has written extensively on China's development experience, south-south cooperation, China's foreign aid

and the Belt and Road Initiative.

### 7、王宏新 (WANG Hongxin)

经济学博士，北京师范大学全球共同发展研究院教授、院长。研究方向：全球发展、减贫、气候变化、生态文明。主要成就：在《Science》《Asia Pacific Journal of Public Administration》《管理世界》《世界经济研究》《国际贸易》等核心期刊发表论文；出版《适应性发展导论》等专著、教材、译著 20 余部；全程参加了中国脱贫攻坚评估工作，具有丰富的政策评估经验；为 Nature、World Development、BJM Global Health 等自然科学和社会科学学术期刊审稿人。



Mr. WANG Hongxin, Doctor of Economics, is Professor and Dean of Academy of Global Development at Beijing Normal University. His research interests are global development, poverty reduction, climate change and ecological civilization. He published papers in journals such as Science, Asia Pacific Journal of Public Administration, Management World, World Economy Studies and Intertrade, and published over 20 monographs, textbooks, and translations such as Introduction to adaptive development. He participated in the whole process of the Evaluation of China's Poverty Alleviation and has rich experience in policy evaluation. He is one of the reviewers of Nature, World Development, BJM Global Health and other international academic journals of natural and social sciences.

### 8、张建平 (ZHANG Jianping)

Mr. ZHANG Jianping is the Deputy Director of Academic Steering Committee, Head and Senior Research Fellow of Regional Economic Research Center, Chinese Academy of International Trade and Economic Cooperation of Ministry of Commerce. He is also Professor of School of Economics at Peking University, the PhD Adviser of the University of International Business and Economics and the Vice President of Chinese Social and Economic System Analysis Research Association. He is an Executive Board Member of Chinese People's Institute of Foreign Affairs, China National Committee for Pacific Economic Cooperation and Chinese Association for International Understanding, Member of Expert Committee of International Trade in Forest Products of State Forestry Administration and China Council for the Promotion of International Trade.

## 9、任琳（REN Lin）

中国社会科学院世界经济与政治研究所全球治理室主任、研究员；中国社会科学院大学教授、博士生导师。毕业于柏林自由大学，获政治科学博士学位；发改委应用经济学博士后。为商务部援助项目教授国际合作与发展等课程。波尔多政治学院客座教授，课程内容为国际政治经济学，全球治理和中国外交。UNESCO 中方组委会相关问题青年专家。研究方向为国际政治经济学、全球治理、大国关系。



Ren Lin, senior fellow, director of the department of Global Governance, Institute of World Economics and Politics, Chinese Academy of Social Sciences. She is also a Professor and Doctoral supervisor at the University of Chinese Academy of Social Sciences. She received Ph.D degree in Political Science from Free University Berlin; and has a post-doc experience in Applied Economy in the National Development and Reform Commission. She teaches international cooperation and development for the Ministry of Commerce. She used to be a guest professor at Science Po Bordeaux and taught a course on “International Political Economy and China’s Participation in Global Governance”. She serves as a young expert on relevant issues at the UNESCO Chinese Organizing Committee. Her research area includes International Political Economy; Global Governance, Relations among Major Powers.

#### 10、张海滨（ZHANG Haibin）

北京大学国际关系学院副院长、教授，北京大学国际组织研究中心主任，北京大学碳中和研究院副院长，北京大学全球健康发展研究院副院长。主要从事国际组织与全球治理、国际环境和气候政治、中国环境外交等研究。兼任中国国家气候变化专家委员会委员、中国商务部贸易与环境专家组成员、中国联合国协会常务理事、中国文化与旅游部国家文化和旅游公共服务专家委员会委员、德国外交部气候与安全专家组成员、中国环境文化促进会理论界委员、中华医学会全球卫生委员会委员。



Dr. ZHANG Haibin is the Vice Dean and Professor of the School of International Studies, Director of the Center for International Organization Studies, Peking University(PKU), Vice Dean of the Institute

of Carbon Neutrality, PKU and the Vice Dean of the Institute of Global Health and Development, PKU. His major research areas are international organizations, international climate politics and China's environmental diplomacy. He is the member of China's National Expert Panel on Climate Change, adviser to the Ministry of Commerce, China, on trade and environment issues ; member of the Board of United Nations Association of China ; adviser to the Ministry of Culture and Tourism China, on public service issues; adviser to the Ministry of Foreign Affairs, Germany, on climate and security issues; member of Governing Council of China Environment Culture Promotion Association ; member of Governing Council of China Society for Environmental Resources Law; and member of Global Health Council of Chinese Preventive Medicine Association.

#### 11、陈迎（CHEN Ying）

息对策研究类二、三等奖。

Dr. CHEN Ying, is a Senior Research Fellow at Research Institute for Eco-civilization (RIEco), Chinese Academy of Social Sciences (CASS), Deputy Director of CASS Research Center for Sustainable Development (RCSD) and Professor at CASS Graduate School, Lead Author of Intergovernmental Panel on Climate Change (IPCC) the Fifth Assessment Report (AR5) and AR6 Working Group III, member of UNESCO COMEST. She is a vice Chairman of Chinese National Committee for Future Earth (CNC-FE), vice Director of Environmental Economics Branch of Chinese Society for Environmental Sciences, vice Director of Climate Change and Low Carbon Development Committee of Chinese Meteorological Society. Her research interests include environmental economics and sustainable development, energy and climate change policy as well as international climate regime etc. She published 4 books (as co-author), over 100 papers in academic books and journals, as well as an amount of reports, analysis and articles. Some of them were awarded for Pushan Award for Excellent Paper on International Economics, Sun Yefang Award for Excellent Paper on Economics and CASS Award for Excellent Research Achievements, etc.

## 12、邹晓龙 (ZOU Xiaolong)

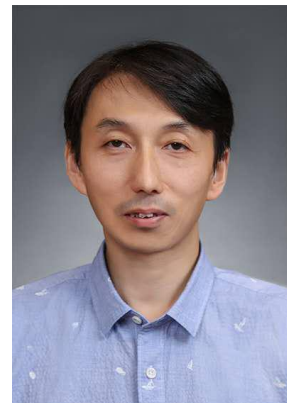

He has served as Chairman of the Board of Directors of Japan for UNHCR, Vice Chairman of CARE International Japan, as well as advisor to the Ministry of Justice (Immigration Services Agency) and the Ministry of Foreign Affairs. ## **Introduction of UNA-China**

The United Nations Association of China (UNA-China) is the only nationwide non-governmental organization in China devoted to the promotion of the purposes and principles of the United Nations Charter. Its membership is open to the general public and social entities that are enthusiastic about the cause of the UN. UNA-China's Board consists of senior diplomats, renowned scholars, entrepreneurs and social activists who are keen on promoting the cause of the UN.

UNA-China is one of the founding members of the World Federation of the United Nations Associations (WFUNA), and the first NGO in China granted General Consultative Status with the UN Economic and Social Council (ECOSOC). It is associated with the Department of Global Communication (DGC) of the UN and also a full member of the Conference of the Non-Governmental Organizations in Consultative Relationship with the United Nations (CoNGO).
